Student's Imprest Account

The following expenses are recovered from the Student's Personal Imprest Account which should be maintained at **Rs 15,000** per student as per the School Policy.

Particulars of charges:

- 1) Uniforms (including winter uniform & sports dress)
- 2) Text books & Note books
- 3) Stationery and other items
- 4) Educational tours/ Long tour excursions
- 5) Personal requirements
- 6) ICSE/ISC Board Registration Charges
- 7) Outside medical consultancy and other charges out of Imprest

Observation period:

- When the child is admitted, the first two weeks is the observation period starting from the first day of admission. In case if the school discontinues the admission of child or if you as a parent/guardian wants to discontinue the admission, in either case only the 1st installment fees, security deposit and imprest amount (balance) will be refunded however admission fees and annual charges are non-refundable.
- Shifting from Residential to Day Scholar is not permitted during the year. If any student does then he should pay Residential fees only. Otherwise shifting is not possible.

- If the student is withdrawn by the parent for any personal reason or by the school for misconduct anytime during the school year, there is no refund of fees & security deposit. Only Imprest deposit will be refunded.
- The Imprest Deposit covers the cost of all chargeable incidentals such as damage to the School property, replacement of lost books & fine etc.
- If a student plans to get transferred to another school, send a written application form or email, 3 months prior to leaving the school and all dues need to be settled. Failing to do so will lead in losing security deposit and imprest deposit.
- A discount of 5% shall be given to those who pay the total year fees as a single payment in the beginning of the academic year.
- Second brother discount is 20% on tuition fees only.
- Late fee penalty of Rs.100/- per day (including holidays) after the due date.
- Meeting of parents and students is not permitted during school working hours.
- Student should Check-In on the given date otherwise penalty of Rs.1000 per day will apply.
- Cheque bouncing is a criminal offence. Kindly honor your cheque otherwise a fine of Rs. 5000/- will be imposed.
- Students will not be permitted to appear in the final exam and no transfer certificate will be issued if the fees are not paid in full.
